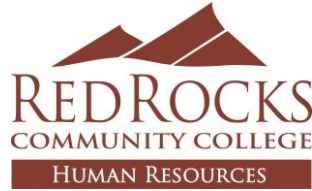


Student Employment Position Announcement



Red Rocks Innovations in STEM Education IDEA Lab Business Technician Work Study

Job Description: As a Red Rocks Innovations in STEM Education (RISE) IDEA Lab Technician, you will be expected to work approximately 10-20 hours per week during office hours which are 8:00 am -5:00 pm Monday through Friday during times when fall and spring classes are in session. All hours will be as a staff/resource person for the IDEA Lab (www.rrcc.edu/idea-lab). The number of hours you work will be at the discretion of the Director of RISE and based on your schedule. There may be additional weekend/evening events or projects that will be necessary. Job duties include but are not limited to:

- Staffing the IDEA Lab and providing appropriate information and mentoring to students, RRCC faculty and industry partners
- Assisting design teams with development of business plans
- Represent RISE and the IDEA Lab at events both on and off campus
- Marketing for RISE and IDEA Lab
- Participate in bi-weekly staff meetings
- Maintaining and securing IDEA Lab equipment
- Creating a safe work environment
- Other duties as assigned

Job Requirements: You must be eligible for student employment (enrolled in a minimum of six (6) credit hours for the fall 2015 semester) and be awarded work-study through Red Rocks Community College to apply.

- Strong interest in promoting innovation at RRCC and in the community
- Excellent written and verbal communication skills
- Demonstrated organizational skills
- Have completed at least 6 credits in BUS, MAN or SBM
- Experience with business plan development and/or marketing helpful, but not required
- Ability to serve as a positive role model for RRCC students
